**Services.** Services available to students of Battle Creek Public Schools ages 10-21.

- \* Treat minor health problems and injuries
- \* Monitor chronic illnesses
- \* Conduct sports, camp, and school physicals
- \* Diagnose and treat STIs (sexually transmitted infections)
- \* Provide HIV testing and counseling
- \* Provide pregnancy testing
- \* Assist with mental health issues
- \* Provide immunizations
- \* Provide health education
- \* Monitor smoking cessation
- \* Offer weight management counseling
- \* Provide information about Medicaid provider resources
- \* Assist with MICHild/HealthyKids application process
- \* Refer to community resources

The SHC does not dispense or prescribe birth control pills or devices or provide abortion counseling, referrals, or services.

**Health Care.** Health care provided by a Nurse Practitioner and Medical Assistant in collaboration with the Calhoun County Public Health Department Medical Director.

- \* SHC consults with students health care providers.
- \* Fees are based on student income and determined on a sliding fee schedule.
- \* Services will be billed to your health insurance.
- \* No student is denied services if they are unable to pay.

## The Student Health Center (SHC)

was established in 1994 to provide a place for students to access health care, recognizing that students at Battle Creek Central had unmet health needs interfering with their learning.



# C

**Consent.** Each student must have a signed consent for treatment on file to access services at the SHC.

- \* Some services, such as pregnancy testing and STI treatment and testing, are considered confidential and do not require parental consent.
- \* Information about the time and length of a visit ONLY may be shared with BCCHS staff.
- \* Information about the visit is not released to teachers, students, or administrators (unless the information or your condition puts you or someone else in immediate danger).
- \* Parents are notified in a medically-appropriate situation.
- \* SHC follows HIPAA rules on protecting confidentiality.
