The Facilities Task Force met on November 23<sup>rd</sup>. Trustee Slaby, Trustee Poole-Gray and herself serve on this Committee. President LaValley reported that Superintendent Kim Carter developed a Property Interest Report Spreadsheet which is a great tool for organizing the various BCPS Properties and includes details of our intentions for each one, specifically:

- The Task Force has given permission for Superintendent Carter to enter into negotiations of a Sales Proposal for Southwestern Middle School.
- Washington received 3 offers and the Committee needs further information on 2 of them.

- The Committee discussed the need to create solid and clear objective criteria for entertaining offers. Two of the criteria will be that all property is being sold "As Is" and the District will not accept less than the appraised value.
- A Proposal was received for Wilson Elementary, which is leased to New Level Sports. The District needs to get this property appraised because we have an offer.
- The first Bond Steering Committee Meeting is scheduled for Thursday, December 16<sup>th</sup> from 3:00-4:30pm. She will represent the Board and will keep the Board Members informed about this process.
